Developed an organizing toolkit and training series about climate justice, and ran three rounds of the training series for 60 people. Supported over 3,000 tech workers who walked out to join the Global Climate Youth Strike. Multiple big tech companies have since made stronger commitments around renewable energy and zero emission transitions. Hundreds of emails and phone calls made to JP Morgan Chase executives, urging them to break ties with the fossil fuel industry. Organized protests at Chase branches and the bank's regional HQ in which several hundred people participated. Built a national network of twenty-five groups actively campaigning around Chase.

4c (Code:) (Expenses \$ 62,605 including grants of \$) (Revenue \$) Movement Support-Activated 40 volunteers to provide support and help carrying out the planning and execution of the Climate Youth Strike, which drew in 15,000 participants. Grew our volunteer base through dozens of outreach events including social hours, book clubs, study groups, house parties, and tabling in stores and at community events. Held monthly general meetings with 20 new volunteers and 75-100 participants. Held 2 or more art builds a month, with an average of 20 volunteers each. Participated in the Fremont Solstice parade, we had over 50 volunteers to help create, build and deploy our climate float in a parade that draws up to 100,000 spectators. Matched community members with skilled volunteers who provided over 100 hours of health and wellbeing services to community members.
